On 23<sup>rd</sup> day of December 2021 the respondent, Tanzanite one Ltd was duly wound up. Following the winding up of the respondent, the court consequently appointed Mr. Mpaya Adalbert Kamara, the learned advocate as Liquidator. The said liquidator filed a preliminary Report on 5<sup>th</sup> day of June, 2022.

However, on 22<sup>nd</sup> November, 2022 the liquidator wrote a letter which was duly received by the court 23<sup>rd</sup> day of November, 2022 on his resignation as liquidator of the respondent pursuant to section 298 (1) of the Companies Act, Cap 212, Revised Edition, 2002

Upon receipt of the liquidator's letter, I summoned the liquidator and Petitioner, Bernard Buhoma. On 5<sup>th</sup> day of December 2022, Mr. Henry (adv), the petitioner and then Kamara entered their appearances. Mr. Kamara and his assistant (Mr. Henry Simian) informed the Court that their intention of resignation is due to the fact that, he faced challenges during his liquidation processes including financial constraint taking into account that his office is in Dar es salaam. On the other hand, the petitioner proposed two persons to be appointed as liquidators namely; Emmanuel Kinabo and Mr. Daniel Lyimo, both are learned advocates.

This court is moved by Mr. Kamara under section 298 (1) of the Companies Act (supra) which reads;
